

Legislative Update

- Governor John Kasich signed the FY2014-15 state budget into law in June 2013, cutting taxes by \$2.7 billion and providing \$1.5 billion in education funding. The budget also includes a plan that will add \$3 billion in federal, state and local funds into Ohio's highways.
- After neighbors Indiana and Michigan passed right-to-work legislation in 2012,

- Ohio legislators also took up the issue in 2013. The legislation didn't go far, however, and the state Chamber of Commerce says that right-to-work is an issue that should be decided via statewide referendum.
- Kasich went against many of his Republican colleagues by backing and moving forward with expansion of the state's Medicaid program.

- According to the third quarter 2013 report, JobsOhio, the state's non-profit economic development organization, entered into agreements with 69 companies in 2013 bringing \$1.2 billion in capital investment with the potential to create or retain over 17,500 jobs.
- Ohio is ranked eighth in the U.S. in terms of Foreign Direct Investment. Germany and Japan are the top two countries investing in Ohio. Only California has more Japanese investments than Ohio.
- Ohio enjoyed the most improved business climate in 2013 according to 736 CEOs nationwide who participated in Chief Executive Magazine's annual best and worst survey.
- In 2013, Ohio Third Frontier Commission, the state's technology-based economic development initiative, approved more than \$12.8 million to fund biomedical companies and assist technology start-ups and entrepreneurs get their businesses up and running.
